

**Subject; Unauthorized absence from duties, Notice thereof.**

Whereas, you are habitual of remaining on unauthorized absent from duty and previously you remained on unauthorized absence for the period since December 2020 to 30<sup>th</sup> March 2021 for which explanation was issued vide the Principal, Govt. Medical College, Kathua No.:- GMCK/Admn/2020-21/4529-33 dated 19.03.2021. After taking a lenient view of your service in this Department and after strict warning, you were allowed to join the duty on 31<sup>st</sup> March, 2021.

Whereas, you are again on unauthorized absence since 17.08.2021 which has been intimated to Higher Authority under this office letter No.:- MS/GMC & AH/K/2021-22/2868 dated 26.08.2021 and on the direction from the office of the Principal, Govt. Medical College, Kathua under letter No.:- GMCK/Admn/2021-22/4029-34 dated 01.09.2021, a show cause notice was issued and delivered to you through one of the employees of this Hospital on 03.09.2021 under proper receipt besides you were also directed to report back to duty vide this office No.:- MS/GMC & AH/K/Notice/2972-73 dated 01.09.2021.

Whereas, your non-reporting to duty has been again intimated to the Principal, Govt. Medical College, Kathua vide this office letter No.:- MS/GMC & AH/K/2021-22/3388 dated 24.09.2021 and on the directions of the Principal, Govt. Medical College, Kathua on 25.09.2021, now through this medium of Notice you are again afforded a chance to report back to the duty within 10 days from the date of its issue besides you are also directed to explain your unauthorized absence alongwith defensive evidence otherwise it will be presumed that you have nothing to say and actions under rules against you will be recommended to the Higher Authority.
