

The appointment of these candidates shall be subject to the following conditions:

The appointees shall report in the Principal Govt. Medical College Kathua within period of 21 days along with i) all the original certificates, two photocopies of all educational and other concerned certificates i.e Permanent Residence Certificate, No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange and Medical Fitness Certificate duly signed by Chief Medical Officer.
