

**Examination Schedule and Instructions:** written/screening Test will be conducted on **03.03.2024** at New Building, Government Medical College, Kathua. All the shortlisted candidates for written/screening Test should report by or before 10:00 AM at the Examination Centre. Written/screening Test will start at 12:00 PM sharp. Separate notice regarding Admit Cards shall be notified online on [www.gmckathua.in](http://www.gmckathua.in) only, one week prior to the written/screening Test.

As such, instructions to report for the written/screening test at GMC Kathua (New Building) are mentioned below:

1. The written/screening Test will consist of Objective Type, Multiple choice questions.
2. Applicants should bring Blue/Black Ball Pen, Identity Proof with photo in Original (Driving License/Aadhaar Card/ Voter Card etc).
3. There is no provision for safeguarding the belongings of the applicants.
4. Any kind of Electronic Items are not allowed in the Examination Hall/s i.e. Mobile Phones, Digital Watches, Calculator, Bluetooth Devices, Pendrives etc.
5. Final decision to allow the applicants to sit in the examination hall shall be of the undersigned.
6. Candidates are required to report at the venue strictly at 10:00 am. Candidates will not be permitted after 11:30 am.
