
As Such candidate next in merit as per "Annexure A" is hereby called for joining. The candidate shall have to join within 10 Days from the issuance of this notification.

- e) If the document filled by me are found wrong/ Incorrect at any point of time, my appointment shall be terminated immediately and disciplinary and legal proceedings shall be initiated against me.
