Whereas, it was already mentioned in the advertisement notice that the vacancies have been advertised as per the posts which are vacant or likely to fall vacant. However, the Department may withdraw/ alter number of vacancies at any point of time till the completion of selection process.

As such, the vacancies advertised in the department of Physiology, Pharmacology and Community Medicine are withdrawn.

Whereas, in the department of Forensic Medicine out of two vacancies only one vacancy fall vacant. So, the selection list for the department of Forensic Medicine is prepared only for the one vacancy.

It is also notified to all the applicants, who have applied for the post of demonstrator in the department of Physiology, Pharmacology and Community Medicine that they can get their application form fees back after submitting the original receipt in the Gazetted Section, Administrative Hall, GMC Kathua with in 07 days of issuance of this notification. Failing which fee shall not be refunded.

All the candidates are also informed that CID verification process is completely online. Candidate should have a valid and working mobile number. It is required for the initiation of the online CID verification process. ANNEXURE-B

The engagement shall, however, be subject to the following terms and conditions:

- Tenure appointment shall be subject to work and conduct of the candidate in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other such activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
- The doctor shall be required to stay in the College/Hospital premise if residential accommodation is available and near college campus in case of non-availability of residential accommodation.
- The candidate shall not indulge in any private practice during his/her tenure and if found doing so his/her tenure appointment shall be terminated forthwith.
- Salary shall be disbursed only after satisfactory report from Inspector General of Police, CID, J&K will be received.
- Any appointee doctor intending to leave the job (after 06 months) shall have to provide one month's prior notice duly forwarded by the concerned HOD or else he/she will have to deposit one month's salary with the institution.
