The appointment of the candidate shall be subject to the following conditions:


- i) The appointee shall report in the office of Principal Govt. Medical College Kathua within period of 21 days along with all the **original certificates, two photocopies of all educational and other concerned certificates i.e Permanent Residence Certificate, No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange and Medical Fitness Certificate duly signed by Chief Medical Officer. In case any appointee does not join within the said period, his/her appointment shall be deemed to have cancelled without any further notice.**
- ii) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID). J&K to whom a reference shall be made by the Principal, GMC Kathua, the candidates shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
- iii) Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authority.
- iv) The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory report in respect of (i), (ii) and (iii) above are received in their favour.
- v) The appointment of this candidate shall be governed by SRO-202 of 2015 dated 30.06.2015.
