Whereas vide notification No. GMCK/Admn/2020-21/2142-48 dated 05.11.2020, posts for staff nurse under NHM were advertised in Govt. Medical College Kathua.

Whereas, vide notification No. GMCK/Admn/2020-21/2787-96 dated 29.12.2020 and No GMCK/Admn/2020-21/2842-46 dated 02.01.2021 the candidates were called for written exam.

Whereas vide notification No. GMCK/Admn/2020-21/3717-21 dated 15.02.2021 the candidates in the ratio of 1:5 were called for interview for post of staff nurse under NHM.

Whereas on 25th of Feb, 2021 date, the interviews of candidates were conducted.

1. The candidates who are provisionally selected as per recommendation of selection committee/assessment committee/ final merit calculation committee are mentioned as Annexure "A" and provisional selection list is also uploaded on site [http:// gmckathua.in/](http://gmckathua.in/).
2. The Selected candidates shall join the office within a period of seven (07) working days from the date of publication of the list, failing which the candidates next in merit shall be allowed to join.

The appointment of the candidates shall be subject to the following conditions:

- i) The appointee shall report in the office of Principal Govt. Medical College Kathua within period of seven (07) working days along with all the original certificates, two photocopies of all educational qualifications, Degree & Diploma duly authenticated by concerned authority and duly registered with J&K State Paramedical and Nursing Council and other concerned certificates as required by DDO for releasing of salary.
- ii) The salary of the appointees shall not be drawn and disbursed by the concerned DDO to them unless the satisfactory report in respect of above mentioned documents is received in their favour.
- iii) The appointment of the selected candidate shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- iv) In case of any objection, if any, may be conveyed to the undersigned within 07 days from issuance of this order.
- v) An affidavit duly signed by 1st Class Magistrate to the effect that:-
 - i. I have understood the terms of contract and shall abide by the terms and conditions of the said post advertised.
 - ii. I will adhere to the roster of duties to be issued by the administration.
