WHEREAS, on the recommendations of the J&K Service Selection Board conveyed vide letter No. SSB/Secy Sel/J/77/2020/2559-65 dated 02.04.2020 and Health & Medical Education Department Civil Secretariat, Jammu letter No ME/NG/New/GMC/04/2019 dated 03.04.2020, 86 candidates were appointed as the **Junior Staff Nurse** in Health and Medical Education Department (Govt. Medical College Kathua).


