

The appointment of the above candidates/doctors as faculty members in these new Government Medical Colleges shall be subject to the following conditions:-

- i) They shall pass the mandatory 'Head Count Test' of the Medical Council of India and in case any of them fails to pass such test, he/she shall revert back to his/her parent Department and shall not have any claim for appointment in the Medical College in which he/she is being appointed.
- ii) The appointment of Consultants/Senior Consultants of Health Department on the posts of Professors/Associate Professors shall also be subject to their confirmation by the Departmental Promotion Committee/Public Service Commission.
- iii) The Consultants/Senior Consultants of Health Department who are being appointed as Professors in these Medical colleges shall be called as '**Designate Professors**' and on completion of three years experience in the capacity of designate Professor, they shall be designated as '**Professors**'.
- iv) The appointment of Dr. Abdul Rashid Badoo, Associate Professor, Department of Orthopaedics GMC, Srinagar as Professor in the Department of Orthopaedics, GMC, Baramulla shall be subject to his clearance by the Departmental Promotion Committee/Public Service Commission.
- v) The lien of these doctors in the parent services/departments shall not be terminated unless they acquire lien on the posts on which they are being appointed in the respective new Government Medical Colleges.
- vi) The seniority of these doctors as Professors/Associate Professors, as the case may be, in the respective new Government Medical Colleges shall reckon from the date of their appointment in these colleges. Where

two or more doctors are being appointed at the same position in any discipline, the seniority shall be as per the order in which their names appear.

vii) In case the pay, which the above doctors are drawing in the parent services, is higher than the pay as would accrue to them on the new posts in the new Government Medical Colleges, their pay to that extent shall stand protected.




