In case appointee does not join within the said period, his appointment shall be deemed to have been cancelled without any further notice.
- ii) Appointee shall give an undertaking in the shape of an affidavit (1st Class Magistrate) to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J&K to whom a reference shall be made by the Principal, GMC Kathua, the candidate shall

- iii) In addition, candidate shall give an undertaking that he shall be required to stay in the college/hospital premises if residential accommodation is available and near college/hospital campus in case of non availability of residential accommodation.
- iv) The salary of the appointee shall not be drawn and disbursed by the concerned DDO to him unless the satisfactory report in respect of (i), (ii) and (iii) above are received in their favour.
- v)The appointment of the candidate shall be governed by under Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 dated 17.06.2020 and S.O 193 dated 17.06.2020.
