The post will have tenure of a maximum period of three years as per SRO-25 of 2013 dated 28-01-2013.

QUALIFICATION

BDS degree from an institution duly recognized by the Dental Council of India. The candidate with higher qualification i.e. (MDS) will be given preference.

TERMS AND CONDITIONS

1. The Non-PSC doctors shall be engaged on consolidated pay equal to basic pay for the post of Assistant Surgeon in the Health Department plus dearness allowance.
2. Maximum age for eligibility to apply shall be 50 years as on cut off date.
