## ORDER-Anti Ragging Committee

- iv. Non Government Organisations involved in youth activities: - **Dr Anil Gupta**, Consultant Surgeon, Associated Hospital, GMC Kathua shall recommend the name of atleast two or more NGOs to the office of the undersigned by or before 28<sup>th</sup> of January, 2021.
