**CORRIGENDUM TO THIS OFFICE EARLIER NOTIFICATION ISSUED UNDER**  
**ENDORSEMENT NO. GMCK/Estt/2019-20/1299-1307 dated 24-09-2019.**

Whereas the applications were invited from the permanent residents of J&K State for engagement of Junior Staff Nurses on Academic Arrangement Basis in terms of SRO-24 dated 10-01-2019, initially for a period of one year extendable up to maximum of six years (1 year at a time and subject to good performance and conduct) or till the selection/promotion is made on regular basis in accordance with relevant recruitment rules governing the respective posts by the JKSSB whichever is earlier.

Whereas in order to give due consideration / weightage to the reserved category candidates in the relevant provision of the law under Jammu and Kashmir Reservation Act amended from time to time for the said posts, the fresh applications are being invited from the candidates belonging to reserved and general categories who have not applied earlier as per the above notification.

Whereas the candidates who have already applied for the said post need not to apply and in case, they want to consider their application against reserved category, they have to deposit their relevant category certificate by or before 30<sup>th</sup> of December. However, the candidates whose forms have been rejected earlier may apply again. List of the candidates whose application forms have been rejected on basis of deficient documents in accordance to earlier notification no: GMCK/Estt/2019-20/1299-1307 dated 24-09-2019 is reflected in Annexure A to this Corrigendum/Re-advertisement.

3. Basic/ essential qualification certificates
4. J&K State Nursing Council Registration Certificate
5. Any additional higher qualification certificate.
6. State subject
7. Category Certificate (if any)
8. Any other relevant certificate

Any application form found deficient in any respect shall be rejected without any intimation.

The eligible candidates shall have to appear before the Selection Committee constituted by the Competent Authority at Government Medical College, Kathua along-with all original testimonials and other related documents at the time of Interview. The academic merit shall be calculated as per the preset/preapproved rules for each candidate for the purpose of selection.

However, in case of large number of application forms received, 1:5 candidates will be called for interview.

In case of any dispute, the decision of Chairperson of the selection committee shall be final. The candidate appearing for interview shall not be entitled to any TA /DA.

**The date of interview shall be notified separately.**

**Note:**

1) The Selection shall be made in accordance with the rules prescribed in the Government Order No 130 HME-2018, 131 HME of 2018, 132 HME 2018 dated 19-02-2018 and amendments thereof vide Government Order No. 680-HME Of 2018 dated 10-12-2018. The appointments under these rules shall not entitle the appointee to any preferential claim for regular appointment.

2) Further, the appointment on academic arrangement basis shall by itself stand terminated on the attainment of 63 years of age by the appointee.

3) The academic arrangement shall cease on joining of regular appointed candidates selected and posted by the competent authority on regular basis.

4) The selected candidates shall have to enter into an agreement that they will not leave the institution before the completion of one year's contract. Abandoning/ terminating of the agreement as the case may be paid for one month's prior notice on either side failing which the salary shall not be paid for one month's to the incumbent which shall always remain in deposit with the Department and the same be released on completion of term.

5) In-service candidate may not apply.

6) Candidates for the post should not be of more than (63) years of age as on the date of issuance of notice.


