Whereas, vide advertisement notice No. GMCK/Estt/2021-22/3162-65 Dated: 04-01-2022, the walk-in interview was conducted on 21-01-2022 for the posts of Demonstrator in the discipline of Anatomy, Physiology, Biochemistry, Microbiology and Pharmacology.

Whereas, in the advertisement notice only MBBS/MD candidates were called for the posts of Demonstrator.

Whereas, on the date of walk-in interview some M.Sc (Medical) and PhD candidates came to the institution and brought it in the notice of the undersigned that the eligibility criteria for the above mentioned posts also includes M.Sc (Medical) and PhD in the discipline of Anatomy, Physiology, Biochemistry, Microbiology and Pharmacology:

Whereas, keeping in view the genuine demand of those candidates they were allowed to appear in the walk-in interview.

Whereas, it is anticipated that more such candidates with the above mentioned eligibility may be interested in appearing for walk-in interview.
