WHEREAS, on the recommendations of the J&K Service Selection Board conveyed vide letter No. SSB/Secy/Sel/53/J/2019/5415-21 dated 18.10.2019, 53 candidates were appointed to the Storekeeper cum Clerk cum Computer operator of Health and Medical Education Department (Govt. Medical College Kathua).
