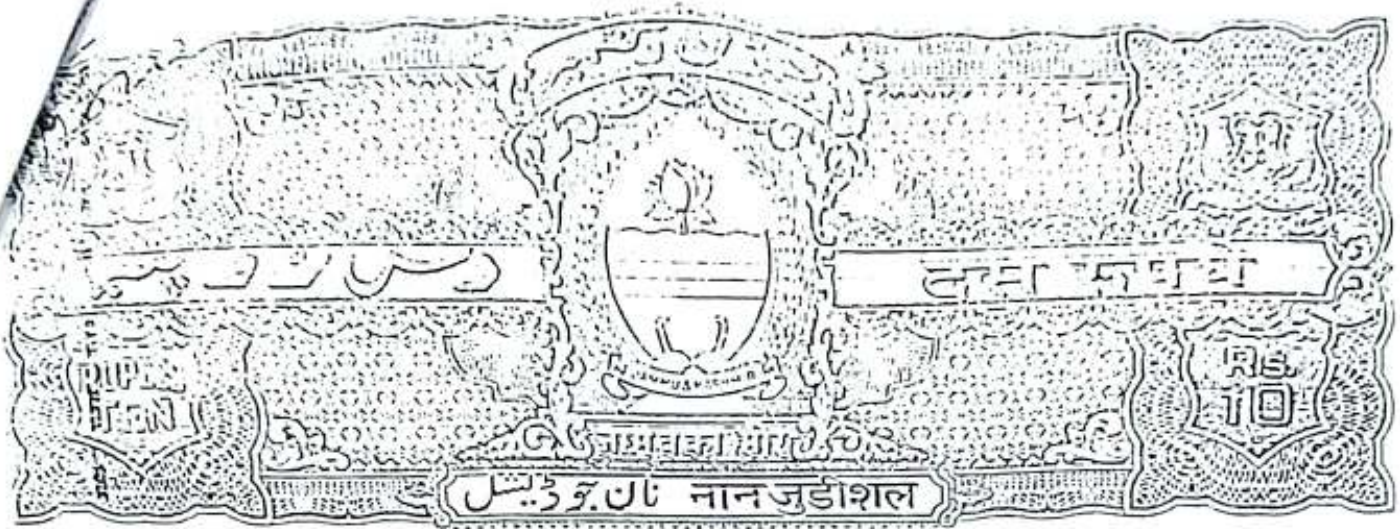

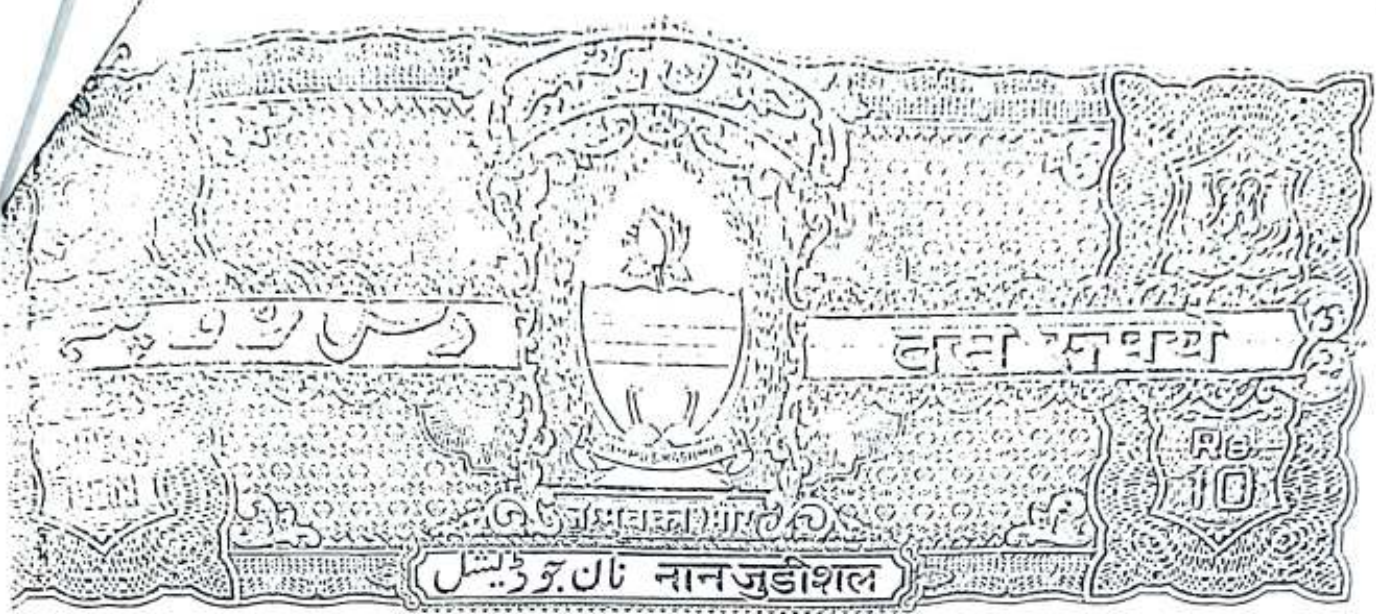

be eligible for admission for the seat during 2020. I shall

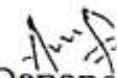

produce the internship certificate to the institution / board during the process of completion of the admission and in any case within one month from the completion of admission process as per MCI Regulation.

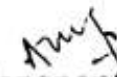

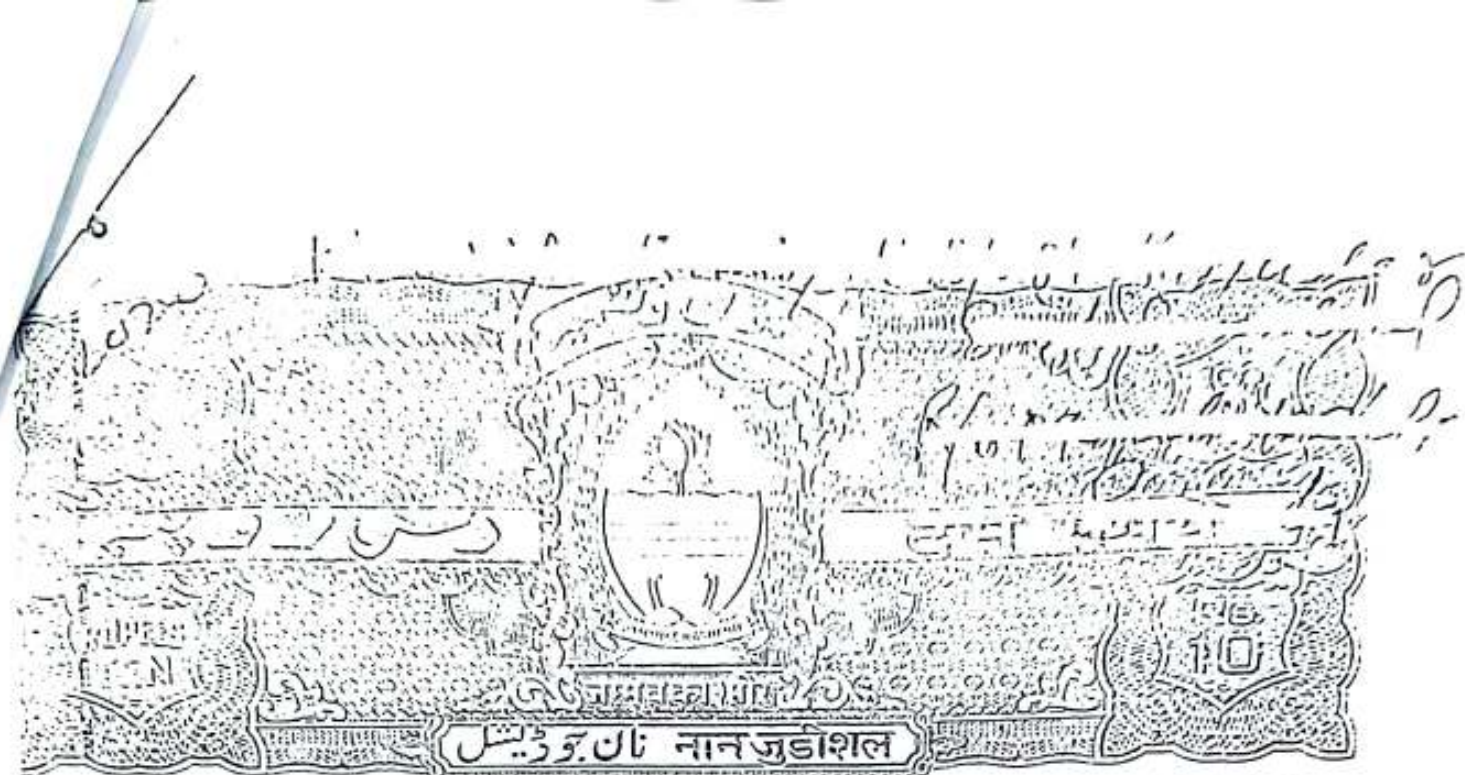

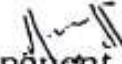
