Sir/Madam,

1 am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 2nd batch of 100 (one hupdred only) MBBS students at Govt. Medical College, Kathua, Jammu & Kashmir u/s 10A of the 1MC Act, 1956 for the academic Year 2020-2021. The Board of Governors has granted approval after consideration of the Comphance Verification Assessment Report (29nd February, 2020), along with the summary/observations of the Member of the Undergraduate Expert Group appointed by the Board of Governors and an undertaking of the Financial Commissioner, Health & Medical Education Department, Govt. of Jammu & Kashmir dated 16.09,2020.
