ANNEXURE-B

The engagement shall, however, be subject to the following terms and conditions: -

- Appointment shall be subject to work and conduct of the candidate in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other such activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
- The candidate shall be required to stay in the College/Hospital premise if residential accommodation is available and near college campus in case of nonavailability of residential accommodation.
- The candidate shall not indulge in any private practice during his/her tenure and if found doing so his/her tenure appointment shall be terminated forthwith
