Sub: Notice to join back duties.

Whereas vide order No. GMCK/Admn/2021-22/5013 dated 30/03/2021, your CCL was sanctioned for 30 days (upto 28/04/2021).

Whereas in view of re-surge of Covid-19 pandemic, all kinds of leaves were cancelled vide communication No. GMCK/Admn/2021-22/211-16 dated 10/04/2021 and accordingly you were supposed to join duties but you have not turned back which is sheer violation of instructions issued by this office.

Whereas vide order No. GMCK/Admn/2021-22/895-899 dated 11/05/2021, you were given three (03) days time to join back your duties. However, despite the expiry of considerable time period you failed to join your duties.

Whereas vide order No GMCK/Admn/2021-22/1294-1300 dated 02/06/2021, it was categorically made clear to you that the period after your sanctioned leave shall be considered as period of unauthorized absence.

Whereas vide above mentioned reference you were given final notice to join back this institution by or before 06th of June, 2021 and whereas despite of repeated instructions issued from the office, time and again to join back, but you remained unauthorisedly absent from legitimate duties assigned to you w.e.f 29/04/2021 till date.
