WHEREAS, on the recommendations of the J&K Service Selection Board conveyed vide letter No. SSB/Secy/Sel/J/29/2020/833-39 dated 20.01.2020 and Health & Medical Education Department Civil Secretariat, Jammu letter No ME/NG/New/GMC/04/2019-PF dated 05/02/2020, 03 candidates were appointed as the **Staff Nurse** in Health and Medical Education Department (Govt. Medical College Kathua).

AND WHEREAS, in the appointment order issued vide order No 79 of GMCK of 2020 dated 14.03.2020, it was interalia ordered that the candidate who fail to join within the stipulated time period of 21 days from the date of issuance of the order, his/her appointment shall be deemed to have been cancelled.

WHEREAS, the candidate selected by aforementioned order first approached the office of the undersigned and asked for ID pass to allow her to move during the lockdown period from one district to another.

AND whereas, after the ID was issued to her vide Ref No. GMCK/Admn/2019-20/792 dated 01.04.2020, she did not submitted her joining report, also, subsequently she sent the application regarding her inability to join in Govt. Medical College, Kathua.

The appointment of the candidate shall be subject to the following conditions:

- i) The appointee shall report in the office of Principal Govt. Medical College Kathua within period of 21 days along with all the original certificates, two photocopies of all educational and other concerned certificates i.e Permanent Residence Certificate, No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange and Medical Fitness Certificate duly signed by Chief Medical Officer. In case any appointee does not join within the said period, his/her appointment shall be deemed to have cancelled without any further notice.
- ii) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J&K to whom a reference shall be made by the Principal, GMC Kathua, the candidates shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
- iii) Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authority.
- iv) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (i), (ii) and (iii) above are received in their favour.

- vi) The appointment shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- vii) The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
- viii) The appointment in Divisional Cadre is not transferable from one Division to another or from one Medical College to another.
- ix) The appointment of the selected candidate shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- x) The inter-seniority of the above appointee, shall be as per the merit secured by them in the Selection process as indicated against each in the select list furnished by the J&K Service Selection Board
