The appointment of these candidates shall be subject to the following conditions:

- i) The appointees shall report in the office of Principal Govt. Medical College Kathua within period of 21 days along with all the **original certificates, two photocopies of all educational and other concerned certificates i.e Permanent Residence Certificate, No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange and Medical Fitness Certificate duly signed by Chief Medical Officer. In case any appointee does not join within the said period, his/her appointment shall be deemed to have cancelled without any further notice.**
- ii) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J&K to whom a reference shall be made by the Principal, GMC Kathua, the candidates shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
- iii) Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authority.
- iv) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (i), (ii) and (iii) above are received in their favour.
- v) The appointment of these candidates shall be governed by SRO-202 of 2015 dated 30.06.2015.
- vi) The appointment shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- vii) The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.

- viii) The appointment in Divisional Cadre is not transferable from one Division to another or from one Medical College to another.
- ix) The appointment of the selected candidates shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- x) The inter-seniority of the above appointees, shall be as per the merit secured by them in the Selection process as indicated against each in the select list furnished by the J&K Service Selection Board
