WHEREAS, on the recommendations of the J&K Service Selection Board conveyed vide letter No. SSB/Secy/Sel/J/55/2019/6116-22 dated 18.12.2019 and Health & Medical Education Department Civil Secretariat, Jammu letter No ME/NG/New/GMC/04/2019 dated 24/12/2019, 22 candidates were appointed to the **Nursing & Paramedical Staff/Technical Assistant / technician** in Health and Medical Education Department (Govt. Medical College Kathua).

AND WHEREAS consequent upon, in the appointment order issued vide order No 23 of GMCK of 2020 dated 06.01.2020, it was inter-alia ordered that the candidates who failed to join within the stipulated time period of 21 days from the date of issuance of the order, his/her appointment shall be deemed to have been cancelled.

AND WHEREAS, consequent upon the non joining of candidates in stipulated time period cancellation order as well as corrigendum to that order was issued vide order No.32 of GMCK of 2020 dated 04.02.2020 and vide order No. 55 of GMCK of 2020 dated 18.02.2020 respectively.

AND WHEREAS, consequent upon the non joining of the candidates within the stipulated time period a waiting list was issued vide order No 60 of GMCK of 2020 dated 27.02.2020 in which inter-lia it was again ordered that the candidates who fail to join within the stipulated time period of 21 days from the date of issuance of the order, his/her appointment shall be deemed to have been cancelled.
