## ORDER

Whereas, vide notification issued under advertisement Notice No. GMCK/Advt-G/2024-25/36 Dated: 05.02.2025, the provisional selection list for the post of Senior Resident in various disciplines was published vide order No. GMCK/E-I/2024-25/1105-A dated 12.03.2025; and

Whereas, list of the waiting candidates was operated vide this office letter No .:- GMCK/E-1/2024-25/1145 dated 27.03.2025: and

Whereas, representation was received against the operated waiting list for reconsidering the merit of the candidates settled by using a tie breaker; and

Whereas, a committee was constituted and took the final decision to make selections in case of tie in the Written Test. The candidate having higher marks in the Basic Qualification required for the post shall be selected. If the marks of the Basic Qualification are the same, then the candidate possessing a Higher Qualification shall be selected. If the marks of the Written Test and Basic Qualification are the same, and both candidates also have a Higher Qualification, then the candidate shall be selected in descending order of age.

Now, the revised final selection list is notified and candidates are selected as mentioned below.

## ANNEXURE-B

The engagement shall, however, be subject to the following terms and conditions:

- Tenure appointment shall be subject to work and conduct of the candidate in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other such activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
- 2. The candidate shall not claim for any regular appointment/extension in the department.
- The candidate shall be required to stay in the College/Hospital premise if residential accommodation is available and near college campus in case of non-availability of residential accommodation.
- The candidate shall not indulge in any private practice during his/her tenure and if found doing so his/her tenure appointment shall be terminated forthwith.
- 5. Salary shall be disbursed only after satisfactory report from Inspector General of Police, CID, J&K will be received.
- 6. The candidate intending to leave the job (after 06 months) shall have to provide one month's prior notice duly forwarded by the concerned HOD or else he/she will have to deposit one month's salary with the institution.
- In case of any interpretation and relaxation regarding the above terms and conditions is concerned, the decision of the Principal, GMC Kathua shall be final.
